

DBS Treasures – Exclusive Privilege for Overseas Customers Terms and Conditions:

- 1. The promotion period of the Exclusive Privilege for Overseas Customers (the "Exclusive Privilege") runs from 15 April to 31 May 2016, both dates inclusive ("Promotion Period").
- 2. To enjoy the Exclusive Privilege, an overseas customer shall: (i) be a holder of an identity document issued outside Hong Kong, (ii) obtain the promotion flyer that is distributed with the Hong Kong Guide MTR Map Edition by DBS Treasures of DBS Bank (Hong Kong) Limited (the "Bank", which expression includes its successors and assigns) during the Promotion Period; and (iii) visit any one of the DBS branches and meet with a Business Development Executive and present the promotion code in the promotion flyer during the Promotion Period.
