

## Current and Savings Accounts – Savings on Tax or Rates and/or Government Rent Payment Promotion ("Promotion") - Terms and Conditions

- 1. The Promotion is only applicable to the selected individual customers (a) to whom the relevant invitation letter ("**Letter**") is addressed ("**Selected Customers**"); and (b) who have maintained DBS Treasures or DBS Account on or before September 30, 2016 with DBS Bank (Hong Kong) Limited 星展銀行(香港)有限公司 (the "**Bank**").
- 2. For the purpose of the Promotion:
  - 2.1. "Designated Deposits Account" means the HKD Current Account or HKD Savings Account printed in the Letter.
  - 2.2. "Daily Closing Balance" is the closing balance of the Designated Deposits Account of each day (based on the Bank's record) during the relevant reward counting period.
  - 2.3. "Reward Counting Period of the Cash Reward" runs from Januarry 21, 2017 to March 20, 2017.
  - 2.4 "Reward Counting Period of the Extra HK\$300 Reward" runs from January 1, 2017 to March 20, 2017.
- 3. To be eligible for the applicable Cash Reward as stated in the Letter, Selected Customers must:
  - 3.1 meet the Lowest Daily Closing Balance Requirement as stated in the Letter in the Designated Deposit Account everyday throughout the Reward Counting Period of the Cash Reward; and

If the requirements in Clause 3 are met, and the Seletced Customer mainatains the any level of Lowest Daily Closing Balance Requirement as stated in the Letter in the Designated Deposit Account in the Reward Counting Period of Extra HK\$300 Reward, the Selected Customer is eligible to receive an extra **HK\$300 Cash Reward**.
- 5. The cash reward will be credited directly to the eligible Selected Customer's Designated Deposits Account on or before April 30, 2017.
- 6. Customer must maintain the Designated Deposits Account at the time any reward is given.
