

## Terms and Conditions for the \$0 Charge for DBS Remit (China, UK and DBS Singapore) Promotion ("Promotion")

- 1. The Promotion is only applicable to customers ("Customers") of DBS Bank (Hong Kong) Limited星展銀行(香港)有限公司 (the "Bank").
- 2. The Promotion runs from 1 April 2017 to 31 December 2017 (the "Promotion Period").
- 3. **"Eligible DBS Remit Transaction"** means any of the following transactions <u>performed via DBS iBanking</u> during the Promotion Period with funds received by recipient bank successfully:
  - i. Transfer RMB to any bank in Mainland China via DBS China Remit service ("DBS China Remit");
  - ii. Transfer GBP to any bank in United Kingdom via DBS UK Remit service ("DBS UK Remit"); or
  - iii. Transfer HKD/SGD to DBS Bank Ltd in Singapore via DBS Singapore Remit service (**"DBS Singapore Remit"**).
- 4. Customers can enjoy \$0 Handling Charge, Cable Charge and Correspondent Bank Charges for <u>ALL</u> Eligible DBS Remit Transactions made:

i.	DBS China Remit	Waived at the time of remittance
ii.	DBS UK Remit	Waived at the time of remittance
iii.	DBS Singapore Remit	<ul> <li>Handling Charge and Correspondent Bank Charges: Waived at the time of remittance</li> <li>Cable Charge: HK\$100 charged at the time of remittance but rebated subsequently ("DBS Remit Charge Rebate")</li> </ul>

5. DBS Remit Charge Rebate will be credited to the Customer's DBS HKD current account or HKD savings account (if Customer does not have a HKD current account) according to the transaction completion date of the Eligible DBS Remit Transaction:

Phase	Transaction Date of Eligible DBS Remit Transaction	Date of DBS Remit Charge Rebate
1	From 1 April 2017 to 31 May 2017	On or before 31 July 2017
2	From 1 June 2017 to 31 July 2017	On or before 30 September 2017
3	From 1 August 2017 to 30 September 2017	On or before 30 November 2017
4	From 1 October 2017 to 31 December 2017	On or before 28 February 2018

- 6. The date and time a Customer performed Eligible DBS Remit Transaction shall be determined based on the Bank's record.
- 7. Customers must remain registered for DBS iBanking service at the time the Bank waives the relevant charges and/or when DBS Remit Charge Rebate is credited.
- **8.** Participation in the Promotion is subject to there being no abuse/non compliance by the Customer, failing which the Bank will debit the value of the reward from the Customer's account without notice and/or take such action to recover any outstanding amounts.



- 9. The Bank may change the terms and conditions and/or modify/terminate the Promotion without notice. The Bank's decision is final.
- 10. The English version shall prevail if there is any inconsistency between the English and Chinese versions.
