RISK DISCLOSURE STATEMENT FOR THE APPLICATION OF SINGLE MANAGEMENT CONTROL IN THE DEALONLINE SERVICE

採納 DEALONLINE 服務單一管理監控模式的風險披露聲明

DealOnline - 單一管理監控 (只需單個用戶即可經手和批核交易)。

This disclosure statement discusses the characteristics and risks of having a single management control ("Single Management Control") for transactions initiated through the DealOnline service provided by the Bank. For all transactions initiated through the DealOnline service, only Single Management Control is available. Single Management Control is a procedure whereby only one single person is required to complete a specified process and initiate and approve transactions. When compared to Dual Management Control which requires two or more people to complete a transaction (one to create and another one of a higher authority to approve), there is a higher risk of fraudulent actions in respect of Single Management Control.

本披露聲明論述採納單一管理監控模式 (「單一管理監控」)於星展銀行提供的 DealOnline 服務進行交易之性質和風險。透過 DealOnline 服務進行的交易一律只提供單一管理監控。在單一管理監控的程式規定下,僅需一名人士即可完成特定項目及同時經手及批核交易。相對於雙重管理監控模式須由兩名或以上人士參與特定項目(即由一人負責在系統訂立交易,而另一名具有較高權力的人士則負責批核交易),單一管理監控模式因而發生欺詐行為的風險較高。
