Terms and Conditions for "Travel Package Reward" ("Promotion")

The following Terms and Conditions shall be read together with the Terms and Conditions for Welcome Offers of DBS Treasures Private Client ("Welcome Offer T&C"). Unless otherwise stated, terms defined in the Welcome Offer T&Cs shall have the same meaning in the Terms and Conditions of this Promotion.
