一般条款及细则

- 1. 本推广由 2018 年 10 月 1 日起至 2018 年 12 月 31 日止(「**推广期**」)。
- 2. 如要参与本推广作为推荐人(「**推荐人**」),必须于 2019 年 2 月 28 日 (「**推荐奖赏回赠日**」)或之前符合以下其中一项要求:

DBS Treasures Chinese Customer Member-Get-Member Program (the "Promotion") Terms and Conditions:

General Terms and Conditions

- 1. The Promotion runs from 1 October 2018 to 31 December 2018 ("Promotion Period").
- 2. To participate in the Promotion as referrer (the "**Referrer**"), he/she must fulfill one of the following on or before 28 February 2019 ("**Referral Reward Date**"):
 - a. maintain any current or savings account at DBS Bank (Hong Kong) Limited 星展銀行(香港)有限公司 (the "Bank") whether in sole name or joint names; or
 - b. hold any DBS credit card ("Card") as a principal cardholder.
- The Referrer is eligible for the Referral Reward if ALL of the following conditions are fulfilled ("Successful Referral"):
 - a. the Referrer refers a Referee (as defined in Clause 4) to become a new DBS Treasures customer with the Bank (the "New Customer") during the Promotion Period by providing personal information to the Referee for completing the DBS Treasures Chinese Customer Member-Get-Member Program Referral Form (the "Referral Form") for becoming a New Customer;
 - b. the Referee completes the Referral Form at one of the branches of the Bank prior to or on the same day when the Referee becomes a New Customer ("Joining Date");
 - c. the Referee successfully becomes a New Customer during the Promotion Period;
 - d. the Referee has not held any product or service except for DBS credit card (whether in single name or joint names) with the Bank at any time during the 12 months preceding the Joining Date;
 - e. the Referee maintains Total Relationship Balance of HK\$1,000,000 or above or its equivalent on 31 December 2018.
 - f. the Referrer must maintain a valid current / savings account / Card at the time the reward is given;
 - g. the Referee must be a DBS Treasures customer at the time the reward is given.
- 4. "Referee" means a person who holds a valid Resident Identity Card or Passport issued by the People's Republic of China excluding any holder of a valid Hong Kong Special Administrative Hong Kong Region Identity Card or Passport.
- 5. The calculation of "Total Relationship Balance" is the total assets that a New Customer maintained with the Bank, regardless whether it is solely or jointly owned by the New Customer. The assets include Hong Kong dollar, Renminbi and foreign currency deposits, Currency Linked Investment, market value of local and overseas securities, investment funds, bonds and other linked or structured investment products.
- 6. If a Referee is referred to the Bank by more than one Referrers and the Referee successfully becomes a New Customer, only the Referrer whose name appears on the Referral Form first submitted to the Bank will be eligible for the Referral Reward. The Bank's decision as to who submits the Referral Form first is final and conclusive.
- 7. A Referrer cannot refer himself/herself or any staff of the Bank in this Promotion. Bank staff is not eligible to participate in the Promotion.
- 8. A Referrer and a Referee cannot refer each other in this Promotion.
- 9. Before making any referral, the Referrer must have informed the Referee about the Referral Reward that the Referrer will be entitled to under the Promotion.
- 10. Before completing and submitting the Referral Form, the Referee must have informed the Referrer that he/she is joining this Promotion.
- 11. Referrer and Referee cannot enjoy the Promotion in conjunction with DBS Treasures Member-Get-Member Program.
- 12. All rewards are non-exchangeable. The Bank can replace the rewards with other rewards without prior notice.



- 13. Participation in the Promotion is subject to there being no abuse/non-compliance by the Referrer or Referee, failing which the Bank will debit the value of the reward from the Referrer's account without notice and/or take such action to recover any outstanding amounts.
- 14. The Bank may modify/terminate the Promotion without notice. The Bank's decision is final.
- 15. The English version shall prevail if there is any inconsistency between the English and Chinese versions.

Specific Terms and Conditions

16. Referral Reward

- a. Upon each Successful Referral within the Promotion Period, the Referrer will be eligible to HK\$1,500 cash reward / credit spending ("Referral Reward") for every Successful Referral.
- b. There is no maximum limit on Referral Reward for a Referrer.

17. Bonus Reward

- a. Where the Referrer refers 3 or more Referees during the Promotion Period and are Successful Referrals, the Referrer shall be entitled to Helicopter Victoria Harbour Experience for two (total value at HK\$4,320) ("Bonus Reward") on top of the Referral Reward.
