

"Year of the Ox Fortune Lucky Draw" ("Promotion") – Terms and Conditions:

- 1. The Promotion is only applicable to individual customers ("**Customers**") who hold a DBS Treasures account ("**Eligible Account**") with DBS Bank (Hong Kong) Limited (the "**Bank**") as of 23 February 2021 and maintain the Eligible Account up until 31 March 2021.
- 2. The Promotion runs from 1 February 2021 to 23 February 2021 (the "Promotion Period").
- 3. "Eligible Transaction" means each transaction from Eligible Account via DBS iWealth® app, DBS digibank app, DBS digibank HK (when launched) or DBS iBanking ("Eligible Digital Channels"):
 - Faster Payment System transfer of HK\$50 or above (or equivalent in foreign currencies) through mobile number or email address via PayFast; or
 - Online DBS Remit or overseas fund transfer transaction of HK\$50 or above (or equivalent in foreign currencies) (any transfer of USD to a Hong Kong local bank is excluded).
- 4. Customers who complete 10 or more Eligible Transactions during the Promotion Period will be eligible to enroll into the "Lucky Draw" with details set out in Table 1 below:

- 5. The Prize will be credited directly to the HKD Current Account under the Eligible Account of the "Winners" on or before 31 March 2021 ("Fulfilment Period").
- 6. Customers must maintain a valid HKD Current Account under the Eligible Account at the time the Bank credits the Prize.
- 7. 110 Winners of the Lucky Draw shall be drawn by the Bank. The Bank's records as to whether a Customer is eligible for entry and how many entries shall be final and conclusive.
