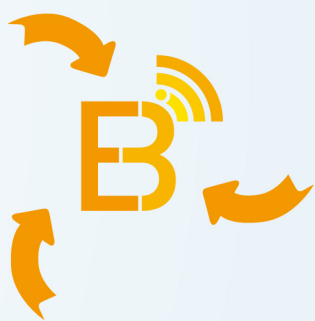

Q1

如果我已經透過 EBPP 服務登記收取水費單及徵收差餉及/或地租通知書的電子賬單摘要，我會否繼續收到郵寄水費單及徵收差餉及/或地租通知書？  
Can I continue to receive paper bills after registering the EBPP service for Water Bill and Demand for Rates and/or Government Rent?

When should I register for EBPP service if I would like to receive e-Bill summaries for my next Water Bill or Demand for Rates and/or Government Rent through EBPP service?

徵收差餉及/或地租通知書須於3月、6月、9月或12月5日前登記。水費單須參閱上一期的發單日期，並於下一期賬單的發單日期前兩星期登記。  
For Demand for Rates and/or Government rent, you should register on or before 5th of March, June, September or December.  
For Water Bill, please check your last bill for the bill issuance date. You should register 2 weeks before the issuance of your next Water Bill through EBPP service.
