The Assets under Management include Hong Kong dollars, renminbi and foreign currency deposits, market value of local and overseas exchange listed securities, investment funds, bonds, and other linked or structured investment products. <p><u>Point 5</u></p> <ul style="list-style-type: none">The Bank reserves the right to make final decision on all matters regarding calculation of Assets under Management and the charging logic of the applicable fees and charges
