Notice of Amendment to the DBS Private Bank Fee Schedule

Effective from 30 June 2023 (The "Effective Date"), Account Service Fee (*Applicable only to accounts with Assets under Management ("AUM") of less than HKD 25,000,000 or its equivalent for the previous 6 consecutive months*) of Other Charges section under the DBS Private Bank Fee Schedule will be changed as follows:

Prevailing	Revised
HKD 15,000 (or its equivalent) per annum per account entity (payable semi-annually) This applies to joint-name and single-name accounts with a common account holder	HKD 24,000 (or its equivalent) per annum per account entity (payable semi-annually) This applies to joint-name and single-name accounts with a common account holder

The first account service fee (to be charged based on client's AUM from 1 July to 31 December 2023) will be collected on month-end of January 2024.
