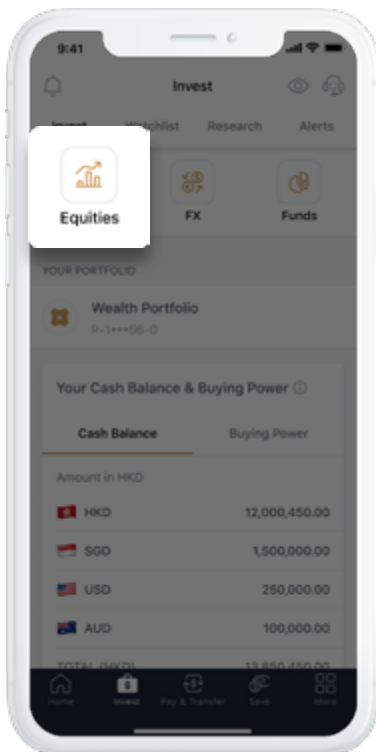
To search/trade in US or CA markets, you need to accept the "Exchange Agreements" and submit your W-8 form.

To accept your "Exchange Agreements", via Internet Banking, you can go to **Invest > Equity > My Account > Account Management > Market Data for US/CA**.

To submit your W-8 form, you can reach out to your Relationship Manager for more details.

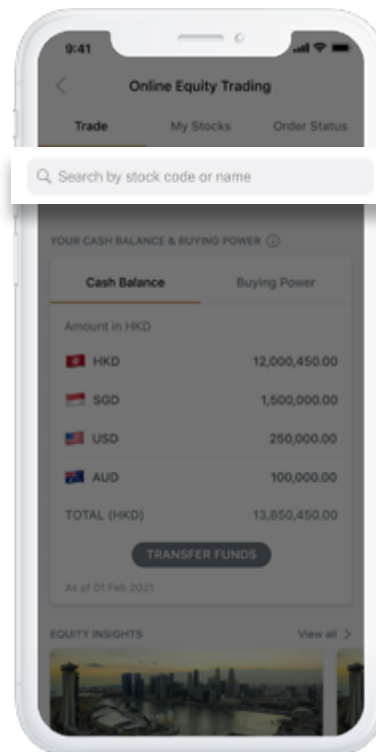

# Take advantage of preferential FX rates

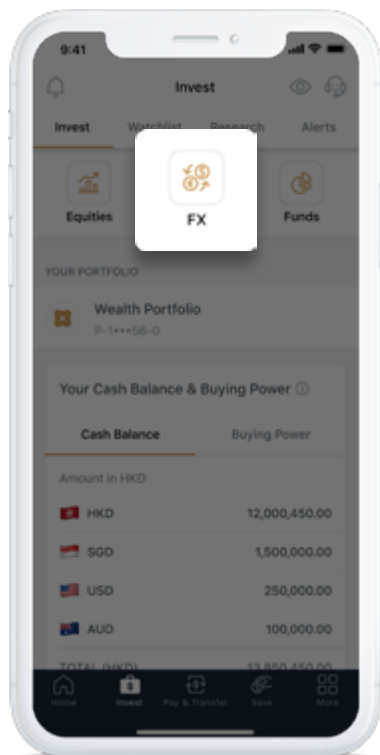

1. DBS Remit covers transferring INR to India, IDR to Indonesia, PHP to Philippines, USD to United States, CAD to Canada, GBP to United Kingdom, AUD to Australia, SGD to Singapore, CNY to Mainland China, EUR to Eurozone destinations, JPY to Japan and THB to Thailand.
  2. In most cases, funds can be transferred on the same day for instructions placed before the cut-off time on Monday to Friday (except public holidays). Actual date and/or time of receipt is subject to the cut-off time, public holidays or processing time of the correspondent bank/recipient bank.
  3. An inward remittance fee may be applied by your recipient bank for the transferred amount. Please contact the recipient bank for details.

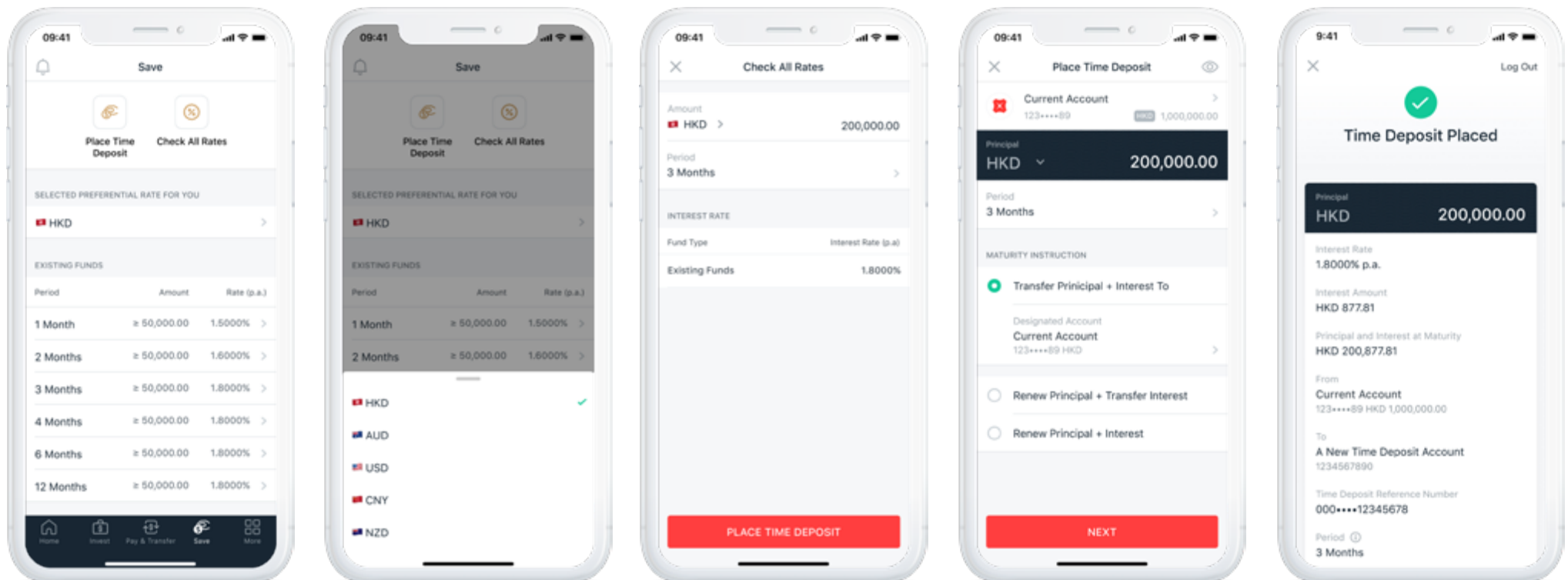
