

DBS Bank (Hong Kong) Limited Notice of Change

With effect from 3 January 2018 (the "Effective Date"), the spending reward of the following credit cards will be revised:

A. Applicable to DBS Eminent Card (including DBS Eminent Visa Signature Card and DBS Eminent Visa Platinum Card) and DBS Platinum Credit Card

Starting from the Effective Date, transactions in Hong Kong Dollars at the point of sales (in case of online transactions, the place of registration and/or settlement of the merchant) outside Hong Kong will not be regarded as "Eligible Spending". In other words, cardholders will not earn any DBS\$ for such transactions.

B. Applicable to DBS Credit Card (excluding DBS Co-branded Card, DBS Pay Less VISA, DBS Black Card, COMPASS VISA, DBS Business Card and Private Label Card)

The promotion period of "3X DBS\$ Reward on All Local Dining" will end on the Effective Date. For spending at local restaurants posted on or after the Effective Date, cardholders shall earn DBS\$ in accordance with the DBS\$ Reward Scheme Terms and Conditions.

C. Applicable to COMPASS VISA

Starting from the Effective Date, for purchase made with Card Interest-free Instalment Loan at designated merchants, cardholders shall earn \$1 COMPASS Dollar for every HK\$250 worth of Eligible Spending.
