

**“DBS x Samsung Shopping Reward” Terms and Conditions (Revised version: extension of the promotion period in clause 2. The deleted contents are marked with strikethrough lines while the newly inserted contents are underlined for easy reference.)**

1. “DBS x Samsung Shopping Reward” Promotion (the “**Promotion**”) is only applicable to the cardholders of DBS Credit Cards and Co-branded Cards (excluding Business Cards) (“**Applicable Credit Cards**”) (“**Cardholders**”) issued by DBS Bank (Hong Kong) Limited (the “**Bank**”).
2. The Promotion runs from 1 September to ~~31 December 2025~~ 20 February 2026 (both dates inclusive) (“**Promotion Period**”).

3. The Promotion is applicable to Samsung Online Shop (<https://shop.samsung.com/hk/en>)\*, Samsung Shop APP (“Shop App”) and designated Samsung Experience Stores (collectively referred to as “**Merchant**”).

4. During the Promotion Period, Cardholder who conducts a single net spending with the Applicable Credit Card at the Merchant and the net spending amount reaches the amount specified in the below table (“**Eligible Transaction**”) is entitled to the corresponding cash rebate (“**Shopping Reward**”):

Eligible Transaction Amount	Shopping Reward
Spending HK\$3,000 to below HK\$6,000	HK\$150
Spending HK\$6,000 to below HK\$10,000	HK\$400
Spending HK\$10,000 to below HK\$15,000	HK\$800
Spending HK\$15,000 or above	HK\$1,200

5. For the avoidance of doubt, the following types of transactions are not considered as Eligible Transactions:
  - a) Transactions that are subject to cancellation, charge-back, return of goods and/or refund,
  - b) Transactions completed at designated Samsung Experience Stores listed above under Card Interest-free Instalment Loan and Credit Card Interest-free Merchant Instalment Plan;
  - c) Unposted transactions at Merchant;

- d) Transactions made with Applicable Credit Cards via electronic wallets other than Samsung Pay, Apple Pay, Google Pay; and
  - e) Other transaction as determined by the Bank from time to time.
6. If there is a supplementary card under the Cardholder's Applicable Credit Card, the Eligible Transaction completed by the supplementary card and the Shopping Reward entitled by the Eligible Transaction will be aggregated with that of the principal card account.
  7. Unless otherwise specified, Shopping Reward cannot be enjoyed in conjunction with other promotional discounts or offers, cash coupons or membership benefits of the Merchant. For details, please check with the Merchant.
  8. Each Cardholder can enjoy a maximum of HK\$2,000 Shopping Reward with each Applicable Credit Card under this Promotion.
  9. The Shopping Reward entitled by the Cardholder will be credited to the Applicable Credit Card account on or before 31 March 2026 and shown on the monthly statement.
  10. The Shopping Reward is only applicable to Cardholders whose Applicable Credit Card accounts are valid, not in default and in good standing (as determined by the Bank at its sole discretion) during the Promotion Period and when the Shopping Rewards are issued. If the status of a Cardholder's Applicable Credit Card account is not in good standing, the Bank reserves the right to disqualify the Cardholder from participating in the Promotion and/or enjoying the Shopping Rewards.
  11. The Shopping Reward entitled by Cardholders shall be determined by the Bank at its sole discretion based on the Bank's record (including time and date). Cardholders must retain the original transaction slips of any transactions. In case of any disputes, the Bank reserves the right to require Cardholders to submit the relevant original transaction slips, other documents or evidence for verification. The submitted transaction slips, documents and/or evidence will not be returned. If there is any discrepancy between the Bank's record and the Cardholder's record of any transaction, the Bank's record shall prevail.
  12. The Bank is not the supplier of the products/services. The description, photos or reference price (if any) in relation to the products/services, which are intended to be for reference only, are not provided by the Bank as well. Any enquiry, claim or complaint in relation to the quality or availability of the products/services or the accuracy of any of the aforementioned information shall be directed to the Merchant. The Bank shall assume no liability in respect thereof.
  13. Participation in this Promotion is subject to there being no abuse or non-compliance by the Cardholder, failing which the Bank will debit the values of the Shopping Reward from the Cardholder's account without notice and/or take such action to recover any outstanding amounts.
  14. The Bank and the Merchant may change these terms and conditions and/or modify or terminate the Promotion. The Bank and the Merchant's decision are final.
  15. The English version shall prevail if there is any inconsistency between the English and Chinese versions.
  16. Promotion information will remain accessible up to one week after the end of the Promotion.
