<u>Terms and Conditions for Selected Customer Online Permanent Increase in Combined Credit Limit and Cash Out to get extra HK\$200 Promotion</u>

- 1. Selected Customer Online Permanent Increase in Combined Credit Limit and Cash Out to get extra HK\$200 Promotion ("Promotion") is only applicable to the principal cardholders of DBS Credit Cards and Co-branded Cards (excluding Business Cards) ("Applicable Credit Card") invited by DBS Bank (Hong Kong) Limited ("the Bank") by SMS or DBS Card+ mobile application ("DBS Card+") push notification ("Selected Cardholders"). The participation eligibility cannot be transferred to others by the Selected Cardholders.
- 2. Promotional period of this Promotion has been already printed on/stated at leaflet/website (both dates inclusive) ("**Promotion Period**").
- 3. During the Promotion Period, Selected Cardholders who have simultaneously applied for permanent increase in their combined credit limit and Online Cash-out ("Call-a-loan" service) / ("Funds Transfer" service) by using an Applicable Credit Card through DBS "Instant Cash" promotional page or DBS Card+ mobile application whose cash out amount and number of instalments meet the below requirements, can enjoy extra HK\$200 cash rebate ("Extra Cash Rebate").

- 4. During the Promotion Period, each Selected Cardholder can only enjoy the Extra Cash Rebate once. Selected Cardholder will be entitled to the Extra Cash Rebate based on the cash out amount of the "Call-a-loan" / "Funds Transfer" application that was approved during the first successful online permanent increase in combined credit limit.
- 5. The Extra Cash Rebate will be credited to Selected Cardholder's Applicable Credit Card account within 6 months after the end of the Promotion Period and shown in the monthly statement. Extra Cash Rebate are not redeemable for cash and cannot be used to offset or settle the minimum payment of monthly statement. If Selected Cardholder has more than one Applicable credit card, the Bank has the right to decide to credit Extra Cash Rebate in any of the Applicable Credit Card accounts.
- 6. The Promotion is only applicable to Selected Cardholder whose Applicable Credit Card account is valid, not in default and in good standing (as determined by the Bank at its sole discretion) during the Promotion Period and when the Extra Cash Rebate is issued. If a Selected Cardholder's Applicable Credit Card account is not in good standing, the Bank reserves the right to disqualify the Selected Cardholder from participating in the Promotion and/or enjoying the Extra Cash Rebate. In case of disputes, decision of the Bank shall be final and binding.

This Promotion can be used in conjunction with Online Permanent Increase in Combined Credit Limit and Cash Out to get up to HK\$400 Promotion and "Call-a-loan"/ "Fund Transfer" Online Cash Out "Cash Rebate" Promotion at the same time, but it cannot be used in conjunction with other increase credit limit promotions.
