

## 星展特快海外轉賬及匯款幸運大抽獎（「本推廣」）條款及細則

### 一般條款及細則：

1. 本推廣只適用於星展銀行(香港)有限公司(「本行」)的客戶(「客戶」)。
2. 本推廣由 2019 年 5 月 27 日起至 2019 年 7 月 22 日止(「推廣期」)，並分為四個階段進行：第一階段為 2019 年 5 月 27 日至 2019 年 6 月 9 日；第二階段為 2019 年 6 月 10 日至 2019 年 6 月 23 日；第三階段為 2019 年 6 月 24 日至 2019 年 7 月 7 日；第四階段為 2019 年 7 月 8 日至 2019 年 7 月 22 日。
3. 客戶於推廣期內經星展 iBanking 網上理財完成至少一次並且不少於港幣三萬元(或其等值)的星展特快海外轉賬或匯款服務(「合資格海外轉賬」)，即可於指定抽獎時段(「指定抽獎時段」)參加大抽獎。如客戶推廣期內完成兩次合資格海外轉賬，可獲抽獎次數 2 次，如此類推。抽獎次數不限。
4. 客戶可根據以下時間表於其指定抽獎時段進行抽獎。

5. 合資格客戶須於每一階段指定抽獎期間瀏覽 [go.dbs.com/hk-remit-lucky](http://go.dbs.com/hk-remit-lucky)，並於網頁上輸入其轉賬交易編號以參與抽獎。
6. 每一指定抽獎時段會抽出一百位得獎者，有關得獎者可隨機獲得一百元的指定貨幣(「獎賞」)，包括：美元、加元、英鎊、澳元、新加坡元、歐羅及港元。
7. 得獎者必須於發放獎賞時持有本行有效的往來或儲蓄戶口。有關獎賞會以 2019 年 9 月 30 日釐定的匯率作結算至港幣等值，並於 2019 年 10 月 31 日或之前以港幣等值存進相關的往來或儲蓄戶口。
8. 客戶於推廣期內進行合資格海外轉賬的日期及時間概以本行紀錄為準。
9. 客戶參加本推廣中必須不涉及任何濫用/違規，否則本行不會存入獎賞或會從已存入獎賞的客戶戶口扣除獎賞而無須另行通知及/或採取行動以追討任何未償付金額。
10. 本行可修訂以上條款及細則及/或更改/終止本推廣而無須另行通知。本行的決定為最終定論。
11. 本條款及細則的中英文版本如有任何歧異，概以英文版本為準。

## DBS Remit & Overseas Transfer Lucky Draw Promotion (“Promotion”) Terms and Conditions

1. The Promotion is only applicable to customers (the “**Customers**”) of DBS Bank (Hong Kong) Limited 星展銀行(香港)有限公司 (the “**Bank**”).
2. The Promotion runs from 27 May 2019 to 22 July 2019 (the “**Promotion Period**”). The Promotion Period is divided into 4 phases: phase 1 is from 27 May 2019 to 9 June 2019, phase 2 is from 10 June 2019 to 23 June 2019, phase 3 is from 24 June 2019 to 7 July 2019, phase 4 is from 8 July 2019 to 22 July 2019.
3. If a Customer successfully completes a DBS Remit or Overseas Transfer transaction via DBS iBanking with amount no less than HKD30,000 (or equivalent) during the Promotion Period (the “**Eligible Transaction**”), he/she will be eligible to one entry in Lucky Draw (the “**Lucky Draw**”) of the applicable Lucky Draw Period (as set out in Clause 4 below). Customers who complete two Eligible Transactions will be entitled to two entries in the Lucky Draw and so on. There is no limit to the number of entries.
4. Each Customer can participate in the Lucky Draw according to the timetable below:-

5. Eligible Customers are required to visit the Promotion website [go.dbs.com/hk-remit-lucky-en](http://go.dbs.com/hk-remit-lucky-en) in each phase of the Lucky Draw Period and input the transaction reference number to participate in the Lucky Draw.
6. There will be a total of one hundred winners of the Lucky Draw (“**Winners**”) in each Lucky Draw Period. The Winners will receive \$100 of one of the designated currencies (USD, CAD, GBP, AUD, SGD, EUR or HKD) (“**Reward**”) according to the Lucky Draw result.
7. The Winners must maintain a valid current or savings account with the Bank when the Reward(s) is given. To calculate the Reward amount of Lucky Draw, the Bank will convert all currencies into Hong Kong Dollars at the Bank determined exchange rate on 30 September 2019. The Reward(s) will be credited to the relevant current or savings account of eligible Customers on or before 31 October 2019.
8. In case of dispute, the Bank has the final decision on the date and time when a Customer performs an Eligible Transaction under the Promotion.
9. Participation in the Promotion is subject to there being no abuse/non-compliance by the Customer, failing which the Bank will not credit the reward(s) or where it has been credited, the Bank may debit the value of the reward(s) from the account without notice and/or take such action to recover any outstanding amounts.
10. The Bank may change the terms and conditions and/or modify terminate the Promotion without notice. The Bank’s decision is final.
11. The English version shall prevail if there is any inconsistency between the English and Chinese versions.
