

2023 DBS FPS 5th Anniversary Promotion (“Promotion”) Terms and Conditions:

1. The Promotion shall run from 1 August 2023 to 31 December 2023, both dates inclusive (“**Promotion Period**”).
2. The Promotion is only applicable to customers who hold a DBS Treasures or DBS Account (“**Eligible Accounts**”) on or before 31 December 2023 with DBS Bank (Hong Kong) Limited (the “**Bank**”) and maintains the Eligible Accounts up to 30 April 2024 (“**Customers**”).
3. “**DBS Treasures**” and “**DBS Account**” are customer segments of the Bank. “**Customer Segment**” means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
4. “**Eligible Transaction**” means conducting a single fund transfer with an amount of HK\$50,000 or above (or equivalent) for four consecutive months via Faster Payment System (“**FPS**”) during the Promotion Period from other local bank account to the Eligible Accounts.
5. During the Promotion Period, Customers who have completed the Eligible Transaction will be eligible for a HK\$50 Cash Reward (“**FPS User Reward**”).
6. Customers who fulfill the below requirements during the Promotion Period will be eligible to earn an extra HK\$50 Cash Reward (“**eDDA User Reward**”):
 - i. successfully link another local bank account to their Eligible Accounts account via eDDA Transfer In Service (“**eDDA**”) on DBS digibank HK; and
 - ii. perform fund transfer to the Eligible Accounts to complete Eligible Transaction via eDDA; and
 - iii. have **NOT** completed ANY Transaction via eDDA from 1 June 2022 to 31 July 2023 (both dates inclusive); and
 - iv. cannot enjoy Promotion together with DBS Treasures Welcome Offers (August- December 2023).
7. Each Customer is eligible to a maximum of HK\$100 Cash Rewards during the Promotion Period under the Promotion.
8. The FPS User Reward and eDDA User Reward (together “**Cash Rewards**”) will be credited directly to eligible Customer’s HKD Current Account or Savings Account under the Eligible Account on or before 30 April 2024 (“**Fulfillment Period**”).
9. Customer must maintain a valid HKD Current or Savings Account under the Eligible Account at the time the Bank credits the Cash Rewards.
10. Each Customer can only enjoy the Promotion once.

11. Only primary account holder is eligible to the Promotion.
12. Bank staff cannot participate in the Promotion.
13. The Cash Rewards are non-exchangeable. The Bank can replace the Cash Rewards with alternative rewards without prior notice.
14. Eligibility of any transaction for the purpose of this Promotion shall be determined based on the Bank's record. If there is any discrepancy between the Bank's record and the Customer's record, the Bank's record shall prevail.
15. Participation in the Promotion is subject to there being no abuse/non-compliance by the Customer, failing which the Bank will not credit the Cash Rewards or where it has been credited, the Bank may debit the value of the Cash Reward from the account without notice and/or take such action to recover any outstanding amounts.
16. The Bank may change the terms and conditions and/or modify/extend/terminate the Promotion without notice. The Bank's decision is final.
