

**DBS 2024 eWallet Top up Campaign (“Promotion”) Terms and Conditions:**

1. The Promotion is only applicable to customers who hold a DBS Treasures account or DBS account (“**Eligible Accounts**”) on 31 July 2024 with DBS Bank (Hong Kong) Limited (the “**Bank**”) and maintain the Eligible Account until 31 October 2024 (“**Customers**”).
2. “DBS Treasures” and “DBS Account” are customer segments of the Bank. “**Customer Segment**” means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
3. The Promotion shall run from 27 March 2024 to 31 July 2024 (“**Promotion Period**”).
4. “**Eligible Transaction**” means
  - a) making a Single Net Spending of HK\$1,000 or above (or equivalent in foreign currency) with Eligible Account via any of the following two e-wallets:
    - i. Alipay Financial Services (HK) Limited
    - ii. WeChat Pay Hong Kong Limited; or
  - b) conducting a fund transfer of HK\$1,000 or above (or equivalent in foreign currency) to any of the following four e-wallets (being an immediate payment or a scheduled payment completed during the Promotion Period) via DBS digibank HK App or DBS iBanking from any Current or Savings Account under the Eligible Account:
    - i. Alipay Financial Services (HK) Limited
    - ii. WeChat Pay Hong Kong Limited
    - iii. Octopus Card Limited (including Octopus Card and Wallet)
    - iv. HKT Payment Limited (Tap & Go); or
  - c) performing a single App-to-App (“**ATA**”) payment of HK\$1,000 or above (or equivalent in foreign currency) from any Current or Savings Account of the Eligible Account to any Octopus Card or Wallet. ATA is a payment function of the Faster Payment System (“**FPS**”). When a Customer accesses a merchant app or webpage supporting this function via his/her mobile device and select FPS when making payment, the DBS digibank HK app on the mobile device will be invoked automatically for making payment via the FPS. Use of ATA supported by FPS is subject to terms and conditions. Please refer to the terms and conditions relating to Faster Payment System under section M of the Bank Accounts and Services Terms and Conditions.
5. A “**Single Net Spending**” refers to the final posted net purchase amount made with an Eligible Accounts via the Alipay Financial Services (HK) Limited or WeChat Pay Hong Kong Limited e-wallets in a single transaction during the Promotion Period (based on transaction dates). The Offer may be used in conjunction with red packets, merchant discounts, shopping rewards, subject to the actual payment page which shall prevail.

6. Customers who has completed any of the Eligible Transaction(s) **three times** during the Promotion Period will be eligible for **either** of the following offers accordingly:

- i) *Existing user*: Cash reward of **HK\$50** (“**Cash Reward 1**”) for Customers who have completed **ANY Eligible** Transactions mentioned in clause 4 from 1 January 2024 to 26 March 2024; or
- ii) *New user*: Cash reward of **HK\$100** (“**Cash Reward 2**”) for Customers who have **NOT** completed **ANY** Eligible Transactions mentioned in clause 4 from 1 January 2024 to 26 March 2024.

For the avoidance of doubt, a Customer will only be eligible to Cash Reward 1 or Cash Reward 2. For instance, if a Customer has previously transferred to Alipay but transfers to WeChat Pay for the first time, then he/she will only be eligible for Cash Reward 1.

7. Customers who have fulfilled the requirements for Cash Reward 1 or Cash Reward 2 will be eligible to earn an extra HK\$50 Cash Reward (“**eDDA User Reward**”) by additionally fulfilling the below requirements during the Promotion Period:

- i) successfully link another local bank account to their Eligible Accounts account via eDDA Transfer In Service (“**eDDA**”) on DBS digibank HK; and
- ii) perform a single fund transfer of HK\$1,000 or above (or equivalent in foreign currency) to the Eligible Accounts via eDDA from the aforementioned local bank account; and
- iii) had **NOT** completed ANY transaction via eDDA from 1 January 2024 to 26 March 2024.

8. The Cash Reward 1, Cash Reward 2 and eDDA User Reward (collectively, the “**Cash Rewards**”) will be credited directly to eligible Customers’ HKD Current or Savings Account or Multi-Currency Savings Account under the Eligible Account on or before 31 October 2024 (“**Fulfillment Period**”). Each Customer is eligible to a maximum of HK\$150 Cash Rewards during the Promotion Period under the Promotion.

9. Customers must maintain a valid HKD Current or Savings Account or Multi-Currency Savings Account under the Eligible Account at the time the Bank credits the Cash Rewards.

10. Each Customer can only enjoy the Promotion once.

11. Only primary account holder is eligible to the Promotion.

12. Bank staff cannot participate in the Promotion.

13. Eligibility of any transaction for the purpose of this Promotion shall be determined based on the Bank’s record. If there is any discrepancy between the Bank’s record and the Customer’s record, the Bank’s record shall prevail.

14. Participation in the Promotion is subject to there being no abuse/non compliance by the Customer, failing which the Bank will not credit the Cash Rewards or where it has been credited, the Bank may

debit the value of Cash Rewards from the account without notice and/or take such action to recover any outstanding amounts.

15. The Bank may change the terms and conditions and/or modify/extend/terminate the Promotion without notice. The Bank's decision is final.

17. Promotion information will remain accessible up to one week after the end of the Promotion.
