

DBS EUR Local Transfer 2025 Aug-Nov Promotion (the “Promotion”) Terms and Conditions

General Terms and Conditions

1. The Promotion runs from 18 August 2025 to 2 November 2025, both dates inclusive (the “Promotion Period”).
2. The Promotion is only applicable to DBS Treasures and DBS Account customer (the “Customers”) of DBS Bank (Hong Kong) Limited 星展銀行(香港)有限公司 (the “Bank”).
3. In case of dispute, the Bank’s decision on whether a Customer is entitled to the Promotion is final.
4. The Bank may change the terms and conditions and/or modify/terminate the Promotion without notice.
5. The English version shall prevail if there is any inconsistency between the English and Chinese versions.
6. Each Customer can enjoy the Promotion more than once during the Promotion Period.
7. Promotion information will remain accessible for up to one week after the end of the promotion.

Please confirm the beneficiary bank details with your recipient, including but not limited to SWIFT code of RTGS, bank name and address before making the transfer to ensure accuracy.
10. Other handling charges (including but not limited to enquiry / amendment / cancellation of Local Transfer) will be applied if necessary, please refer to the latest Bank Charges Schedule (DBS Account and Treasures customers) for details.
