

星展特快海外轉賬及匯款豐盛理財新客戶獎賞計劃（「本推廣」）條款及細則

一般條款及細則

DBS Remit & Overseas Transfer Treasures New Customers Reward Promotion (“Promotion”) Terms and Conditions

General Terms and Conditions

1. The Promotion runs from 1 July 2019 to 30 September 2019. (the **“Promotion Period”**)
2. The Promotion is only applicable to individual customers with DBS Bank (Hong Kong) Limited 星展銀行（香港）有限公司 (the **“Bank”**) who successfully complete the Personal Account Opening Form and becomes a new DBS Treasures customer during the Promotion Period (the **“New Customer”**). The Bank’s decision on whether a customer is New Customer is final.
3. In case of dispute, the Bank has the final decision on the date and time when a New Customer performs a transaction under the Promotion.
4. New Customer must maintain a valid current or savings account with the Bank when the reward(s) is given. The reward(s) will be credited to the relevant current or savings account of eligible New Customers on or before 31 December 2019.
