Notice of Amendment to the Terms and Conditions for DBS iBanking Service and the Bank Charges Schedule

We would like to inform you that we are going to enhance the online equities trading service under Wealth Management Account. You will have the privilege to trade equities on 3 more markets, namely Australia, Japan and United Kingdom through the DBS iBanking platform.

To facilitate the enhancement of the online equities trading service under Wealth Management Account, please be informed that with effect from 22 October 2016 (the **"Effective Date"**)*, the Terms and Conditions for DBS iBanking Service and the Bank Charges Schedule applicable to you will be revised or supplemented as follows (Unless expressly indicated otherwise, the numbering used in the Terms and Conditions for DBS iBanking Service and the Bank Charges Schedule is adopted in this Notice of Amendment):

1. Terms and Conditions for DBS iBanking Service

28. Exchange Specific Terms (Only applicable to Online Equities Trading Service)

28.1 In relation to information relating to or provided by the Australian Securities Exchange, the Customer agrees that the Customer will comply with any and all requirements in the document entitled "ASX Market Information Products and Service Guide" published by the Australian Securities Exchange and available at www.asxonline.com.

28.2 In relation to information relating to or provided by Tokyo Stock Exchange, the Customer agrees that the Customer will only use such information in accordance with the policies published by Tokyo Stock Exchange available at <http://www.jpx.co.jp/english/markets/paid-info-equities/realtime/tvdivq00000020e5-att/EnglishPolicy.pdf>.

* Any instruction given on a day which is not a trading day will only be processed on the next trading day. Please refer to the Terms and Conditions for DBS iBanking Service for details.
