- 1. The Promotion starts from 1 January 2023 to 31 March 2023, both dates inclusive ("Promotion Period").
- 2. The Promotion is only applicable to individual DBS Treasures customers of DBS Bank (Hong Kong) Limited (星展銀行(香港)有限公司) (the "Bank") who maintain Wealth Management Accounts ("WM Account") and/or Investment Fund Account with the Bank ("Customers").
- 3. Customers who maintain Southbound Wealth Management Connect account with the Bank are excluded from the Promotion. They can enjoy Online Fund Investment Exclusive Offer for Southbound Wealth Management Connect Clients.
- 4. "DBS Treasures" is a Customer Segment of the Bank. "Customer Segment" means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
- 5. During the Promotion Period, Customers who successfully complete Online Fund Subscription via their WM Account and/or Investment Fund Account through a DBS online banking platform can enjoy 0% fund subscription fee up to an aggregate transaction amount of HK\$300,000 or its equivalent. ("Eligible Transaction")
- 6. Customer is required to pay the subscription fee when conducting the Eligible Transaction. Upon verifying the Customer's eligibility for the Promotion, the Bank will reimburse the subscription fee paid by the Customer for the Eligible Transaction by way of subscription fee refund ("Reward").
