1. The Promotion starts from 1 October 2021 to 31 December 2021, both dates inclusive (**“Promotion Period”**).
2. The Promotion is only applicable to individual DBS Treasures customers of DBS Bank (Hong Kong) Limited (星展銀行(香港)有限公司) (the **“Bank”**) who maintain Wealth Management Accounts (**“WM Account”**) and/or Investment Fund Account with the Bank (**“Customers”**).
3. **“DBS Treasures”** is a Customer Segment of the Bank. **“Customer Segment”** means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
