Dear Shareholders,

We are writing to inform you that the following changes will become effective on 13 September 2019 (the "Effective Date"), unless otherwise specified:

#### **Changes to Dealing Day and Valuation Day**

#### (a) Allianz Global Equity

With effect from the Effective Date, the Dealing Day and the Valuation Day of Allianz Global Equity will be changed as follows to reflect the location from which this Sub-Fund is managed:

#### (b) Allianz Global Dynamic Multi Asset Strategy 50

With effect from the Effective Date, the Dealing Day and the Valuation Day of Allianz Global Dynamic Multi Asset Strategy 50 will be changed as follows due to the fact that Japan no longer constitutes a market with majority of investments of the Sub-Fund:

### (c) Impact of the Changes

The above changes will not result in any change to the features and risks applicable to the Allianz Global Equity and Allianz Global Dynamic Multi Asset Strategy 50. Nor will the above changes materially prejudice the existing investors' rights or interests. Save and except the above changes, there is no other change in the operation and/or manner in which the Sub-Funds are being managed.

There will be no change in the fee structure and fee level of the Sub-Funds following the implementation of the above changes. The costs and/or expenses incurred in connection with the changes described above will be borne by the Management Company.

### **Changes to Allianz Asian Multi Income Plus**

With effect from the Effective Date, the investment restriction of Allianz Asian Multi Income Plus will be revised to provide that a maximum of 60% of its assets may be invested in High Yield Investments Type 1 (down from a maximum of 85% previously).

In addition, the Taiwan Restriction will apply to Allianz Multi Income Plus with effect from the Effective Date. Please refer to the section "II Definitions" of the Prospectus for details of the Taiwan Restriction.

### Addition of VAG Investment Restriction

With effect from the Effective Date, the VAG Investment Restriction will apply to the following Sub-Funds:
