REPORT OF THE MANAGER TO THE UNITHOLDERS

DA CHENG CHINA BALANCED FUND (A SUB-FUND OF DCI INVESTMENT TRUST)

Fund Performance

Da Cheng China Balanced Fund (the “Sub-Fund”) seeks to provide long-term growth of capital and income. As at 30 June 2026, the Sub-Fund had net assets attributable to unitholders of approximately RMB 7,954,489,087.

Market Overview

The A-share market trended upward amid fluctuations in the first half of 2026. Both the Shanghai Composite Index and the CSI 300 Index posted gains, extending their strong performance since 2025. Phased shifts in investor risk appetite was the key driver behind A-share market performance throughout this period. From the beginning of the year through February, rising expectations for the roll-out of pro-growth policy measures led to steady recovery in market sentiment, contributing to modest gains for the CSI 300 Index. Between March and early April, the U.S.-Iran conflict triggered a temporary dent in risk appetite, resulting in consolidation and correction of the CSI 300 Index. From mid-April through the end of the first half, marginal easing in geopolitical tensions laid the ground for gradual restoration of investor confidence, and the CSI 300 Index recovered amid market volatility. In terms of market style, small- and mid-caps outperformed large-caps. Sector-level performance diverged significantly, with technology stocks leading market gains, while consumer-related sectors saw the biggest declines.

China's economy continued to grow on the back of internal strength in the first half of the year, reinforcing a development trajectory characterized by overall stability, structural upgrading, and innovation-driven expansion. Emerging growth drivers expanded rapidly, price levels recovered at a moderate pace, and micro liquidity continued to improve. In terms of fundamentals, GDP rose 5% year-on-year in Q1, accompanied by moderate price recovery and better-than-expected export growth. Although GDP growth moderated in Q2, exports remained robust, with accelerating transition from traditional growth engines to emerging ones. Emerging industries, such as advanced manufacturing, digital economy, and modern services, became the primary drivers behind economic growth. Demand in the AI industry chain as well as the power and new energy sectors also exceeded expectations, further strengthening the role of the new economy as a pillar of growth and demonstrating the resilience and vitality of the Chinese economy. Corporate earnings recovery accelerated, industrial profits rebounded, and the overall performance of listed companies showed marginal improvement. Liquidity-wise, leveraged trading remained active, margin financing and securities lending balances registered historical highs, equity-oriented mutual fund offering recovered, and trading activity stood at the higher end in recent times.

Outlook

Looking ahead, China's economy is expected to sustain its trajectory of stable, higher-quality growth through the second half of 2026. Enhanced macroeconomic policy support, coupled with continued improvement in corporate earnings, should provide a solid foundation for the A-share market to sustain stable and healthy growth. Market style is expected to become more balanced, with the valuation gap between technology and traditional sectors gradually narrowing. The fund will pay attention to industries benefiting from the favorable business climate. From a policy standpoint, more countercyclical macroeconomic measures are expected to be introduced to effectively consolidate the foundation for stable economic growth. Fiscal policy is likely to focus on enhancing the quality and efficiency of economic development, while monetary policy is expected to remain highly targeted, providing ample liquidity and anchoring macroeconomic expectations. Together, these measures should foster an appropriate monetary and financial environment conducive to stable economic growth, high-quality development, and orderly financial market operations. In terms of the economy, the AI-driven industrial revolution is expected to trigger a new cycle of capital investment and productivity gains, accelerating the transition from traditional to new growth engines, with emerging industries making even greater contribution to economic growth. As policy support gradually takes effect, growth of fixed-asset investment is expected to stabilize and recover, while recovery in consumer spending is likely to quicken. At the same time, the vulnerability of conventional energy supply laid bare by continued geopolitical uncertainty in the Middle East will reinforce the strategic competitive edge of the power and new energy sectors, which is expected to support rapid expansion in the profitability, production capacity, and export market share of relevant industrial chains. Benefiting from resilient supply chains and competitive energy costs, China's exports are expected to maintain strong growth and further increase their global market share, providing support for currency re-valuation which is expected to lead to RMB staying strong in the second half of the year. Overall, new growth drivers are expected to play an increasingly important role in supporting economic expansion, allowing China's economy to maintain stable and healthy growth. A moderate recovery in price levels is expected to reshape the earnings profiles of listed companies, which, coupled with stronger and more effective policy measures, serves to further improve corporate earnings. Overseas, the global economy is expected to continue the "K-shaped" recovery in the second half of 2026. The Federal Reserve is clearly divided internally over the future path of interest rates, making the upcoming economic data the key variable of future policy decisions. The likelihood of any Fed rate hike this year is likely low.

Looking ahead, the steady recovery in corporate earnings is expected to provide a solid mid- to long-term fundamental anchor for A-share market performance in the second half. Supported further by ample micro liquidity, the A-share market is likely to enter a more stable phase of development. In terms of market style, the significant valuation gap between technology and traditional sectors observed in the first half of the year is expected to narrow in the second half, leading to a more balanced market style. In terms of investment strategies, the fund will focus on the sectors with strong growth momentum, particularly AI-related industries benefiting from industrial upgrading and technological innovation. At the same time, the fund will also pay attention to energy storage, non-ferrous metals, innovative pharmaceuticals, non-bank financial institutions, fintech and other sectors where marginal improvement in performance is expected.
