Dear Shareholder,

We are writing to inform you of an operational change affecting the Fund in which you are invested. Any terms not defined herein shall have the same meaning as in:

- the extract overseas Prospectus of the Fund and the Hong Kong covering document and the product key facts statements of the sub-funds of the Fund in respect of Fidelity Funds; and
- the Hong Kong Prospectus of the Fund and the product key facts statements of the sub-funds of the Fund in respect of Fidelity Funds 2, (collectively, the "Hong Kong Offering Documents").

Effective **18 August 2025**, the following update was implemented in respect of the Funds:

Appointment of National Financial Services LLC as lending agent

As of 30 September 2025, Brown Brothers Harriman ("BBH"), where acting as one of the two lending agents, will cease providing securities lending services. The Board of each Fund has decided to appoint National Financial Services LLC ("NFS") as a lending agent, replacing BBH, for the Funds' securities lending programme. NFS is a broker-dealer registered under the U.S. Securities Exchange Act of 1934.

The Hong Kong Offering Documents of each Fund will be updated to reflect the appointment of NFS.

Please note that this change does not affect the investment objective, policy, or risk profile of any sub-fund of the Funds.

The Board accepts full responsibility for the accuracy of the information contained in this letter and confirms, having made all reasonable enquiries, that to the best of its knowledge and belief, there are no other facts the omission of which would make any statement herein misleading.

茲致函通知閣下有關基金將會作出的營運變更。本函件未有定義的任何特定詞彙，具有與以下文件中所載相同的涵義：

- 就富達基金的海外認購章程摘錄、香港說明文件及子基金產品資料概要；及
- 就富達基金 2 的香港章程及子基金產品資料概要，(統稱「香港發行文件」)。

自 **2025 年 8 月 18 日起**，基金已實施以下變更：

委任 National Financial Services LLC 為借貸代理

自 2025 年 9 月 30 日起，兩家借貸代理之一的 Brown Brothers Harriman (「BBH」) 將停止提供證券借貸服務。各基金董事會已決定任命 National Financial Services LLC (「NFS」) 以取代 BBH 為基金證券借貸項目的借貸代理。NFS 為按 1934 年美國證券交易法註冊的經紀交易商。

各基金的香港發行文件將予以更新，以反映 NFS 的委任。

請注意，此變更不會影響基金任何子基金的投資目標、政策或風險類別。

董事會對本函件所載資料的準確性承擔全部責任，並確認已作出一切合理的查詢，盡其所知及所信，並無遺漏其他事項，致使本函件所載的任何陳述含有誤導成份。
