We are writing to inform you of certain changes we are making to the Company and the Funds, which are summarised below.

The changes described in this Notice are not expected to have a material impact on investors or on the risk profile, investment strategy, or portfolio construction of the Funds, unless otherwise stated and will be effective on or around 13 August 2025 (the “Effective Date”).

1. Update of the principal adverse impact compliance status of the Management Company

From the Effective Date, the sub-section of the Prospectus titled “*Principal Adverse Impacts – All Funds*” will be revised to clarify that the Management Company will consider the principal adverse impacts of investment decisions on sustainability factors, in accordance with the regime outlined in Article 4 of the Sustainable Finance Disclosure Regulation (SFDR). 2. Miscellaneous clarificatory, administrative, and clerical updates

The revised Hong Kong Offering Documents reflecting the changes in this notice will be available in due course.
