Investment via the Renminbi Qualified Investor ("RQFII") Scheme

The board of directors of Schroder International Selection Fund (the "Company") are writing to advise you of a change to the investment policy of the funds listed above during the March 2019 prospectus update.

The investment policy of each fund was changed to clarify that they can invest in China A-Shares through the Renminbi Qualified Investor (RQFII) Scheme. For the avoidance of doubt, there will be no change to the funds' exposure to China A-Shares, which is less than 30% of their respective assets.

All other key features of the funds and their risk profiles will remain the same. There will be no change in the Funds' investment style or investment philosophy following this change.

Any expenses incurred directly as a result of making this change will be borne by Schroder Investment Management (Europe) S.A., the Company's management company.
