Dear Shareholders.

We, the Hong Kong Representative, wish to advise you that RCM Capital Management LLC, the current Investment Manager of the Sub-Funds, will be merged into Allianz Global Investors U.S. LLC on or around 1 April 2013.

The purpose of the merger is to simplify the legal entity structure in the U.S. and reduce the use of brands by consolidating multiple investment advisers in the region, to bring together all of their businesses and form a more integrated company. The investment management style of the Sub-Funds will not be impacted by the merger. The portfolio managers and investment professionals will be the same. The merger is not intended to, and will not, result in any change in the investment processes, investment strategies or investment techniques currently employed by the applicable portfolio managers and other investment professionals in providing investment advisory services pursuant to the applicable agreements.
