Dear Shareholder,

The Board of Directors of the Company is writing to notify you that on 30 November 2015 (the “**Effective Date**”), BlackRock Investment Management (UK) Limited (“**BIMUK**”) will be appointed as an additional Investment Adviser of the Funds and BlackRock (Singapore) Limited (“**BLKS**”) will also be appointed as an additional Investment Adviser of the US Dollar Core Bond Fund.

The Global Opportunities Fund, World Healthscience Fund and US Small & MidCap Opportunities Fund are currently managed by BlackRock Investment Management, LLC. The US Dollar Core Bond Fund is currently managed by BlackRock Financial Management, Inc.

BIMUK is regulated by the Financial Conduct Authority in the United Kingdom and BLKS is regulated by the Monetary Authority of Singapore. Both entities currently act as the investment adviser of other existing funds that are authorised by the Securities and Futures Commission (“**SFC**”)\*.

The rationale for the abovementioned appointment of BIMUK and BLKS as additional Investment Advisers to the respective Funds is to facilitate an internal reorganisation of investment personnel responsible for the investment management of the Funds. The change will not result in any increase in the fees and expenses borne by the Funds and/or their shareholders. The investment objective and policy and operations of the Funds remain unchanged.

If you do not agree to the above change, you may apply to redeem your shares or switch them into shares of any of the Company’s other sub-funds that are authorised for sale to the public in Hong Kong\* free of any switching, redemption or other charges (other than the anti-dilution costs as set out in Appendix B paragraph 17(c) of the Prospectus) which may be levied by the Company at any time prior to the Effective Date in accordance with the provisions of the Prospectus. Notwithstanding the aforementioned, please note that selected distributors may impose a charge on the conversion or redemption of shares. Please contact your local distributor for further details.

Updated versions of the relevant Hong Kong offering documents will be available at the office of the Hong Kong Representative in due course.
