Unless the context otherwise requires, words and expressions defined in the Prospectus of the Company dated 29 March 2012 and the Supplement dated February 2013 of each Sub-Fund except Investment Legends Fund, in which case the Supplement is dated September 2012 (the "Hong Kong Prospectuses") shall have the same meanings in this letter.

Dear Shareholder

As you are aware, in respect of each Sub-Fund, Barclays Capital Securities Limited's obligations under the Funded Swaps have been guaranteed by Barclays Bank PLC. The respective guarantees are due to expire on 30 March 2014. We would like to inform you that the respective guarantees will be renewed upon expiry of the current guarantee; and in addition there will be a change to the guaranteed amount as further detailed below.

As described in the respective Hong Kong Prospectus of the Sub-Fund (see sub-paragraph titled "Counterparty Exposure" within the "Information for Hong Kong Investors" section), each Sub-Fund invests in one or more Funded Swaps, which is a financial derivative instrument, in order to achieve its respective investment objective(s). The Approved Counterparty to such Funded Swaps is Barclays Capital Securities Limited. Barclays Capital Securities Limited's obligations under the Funded Swap in respect of each Sub-Fund have been guaranteed by Barclays Bank PLC in accordance with a deed of guarantee.

The guarantees expiring on 30 March 2014 will be renewed with a new expiry date of 31 March 2016, unless otherwise terminated in accordance with the terms. Barclays Bank PLC may terminate the guarantee at any time by 30 business days notice in writing to Celsius Funds PLC acting on behalf of the relevant Sub-Fund.

Further, as the size of each Sub-Fund has declined, the amount guaranteed by Barclays Bank PLC will be reduced accordingly to the following amounts:
