Dear Shareholder,

Important: Name Change to certain Share Classes of Fidelity Funds

Fidelity regularly reviews its range of products to ensure that they are clearly labelled and that it is easy for you to identify the different products available.

As part of this ongoing process, the Board of Directors of Fidelity Funds (the "Board") has decided to change the name of the following **gross** investment income-paying Share classes by inserting the letter (G) in the name of such Share classes, as shown in the table below, to indicate the manner in which the relevant Share classes pay distributions to Shareholders.

This name change is designed to clearly reflect the distribution policy of these Share classes. As stated in "3.1 Dividend" under the "General Information" section in Part III of the Hong Kong Prospectus, with respect to the below Share classes, the Directors expect to recommend distribution of substantially the whole **gross** investment income amount for most of the time, and from capital on occasion so as to seek to maintain, so far as is reasonable, a stable payment per Share which should not have over the long term a positive or negative impact on capital. Dividends are normally declared on the first Business Day of each month.

It is important to stress that this name change does not affect the manner in which the relevant funds are managed nor does the existing distribution policy of such Share classes change.

You do not need to take any action as these name changes will take effect automatically from 28 January 2014. Any expense incurred as a result of the above change will be borne by FIL Fund Management Limited as the Investment Manager of Fidelity Funds. There are no changes to the fees charged in relation to these funds or Share classes.
