Dear Shareholder,

For the protection of the interests of the existing shareholders of the Fund, the Directors have resolved to apply an initial charge of up to 5% on subscriptions from Class C, Class I, Class M and Class X Shares into the Fund from **6 December 2013** (the "Effective Date"). With respect to Class A and Class H Shares of the Fund, Shareholders should note that the initial charge of up to 5% on subscriptions, as provided for in the Prospectus may no longer be waived. Please note that any subscriptions into the Fund prior to the Effective Date may also be rejected if necessary.

Please note that only subscriptions to the Fund are affected and you will still be able to redeem your holding or switch it into shares of any other of the sub-funds of the Company ("Sub-Funds")<sup>1</sup> in accordance with the provisions of the Prospectus. Any charges made will not be retained by Henderson Global Investors but will instead be paid into the Fund for the benefit of existing investors.

### Reasons for the decision

The sound investment discipline adopted by the fund manager has proved attractive to investors, leading to substantial net inflows into the Fund over recent months. The Fund has now grown to a size where managing the liquidity of the Fund would be a constraint on the fund manager's current commitment to the lower end of the small cap market.

In order to ensure that the Fund remains nimble and only invests in those investment opportunities where the fund manager has high conviction, the Directors believe that it is in the current best

interests of existing shareholders to impose the Prospectus initial charge provisions on subscriptions in order to seek to avoid the risk of future performance being diluted. Please note that the Fund will be monitored carefully and the situation will be assessed on an on-going basis. Directors retain discretion to act in the interests of the shareholders. Information on the status of the Fund can be obtained at any time at the registered office and at www.henderson.com<sup>2</sup>.
