Change of the investment manager of the sub-funds "Amundi Funds – Equity Global Luxury and Lifestyle, Amundi Funds – Equity Global Agriculture, Amundi Funds – Equity Global Resources" (the "Sub-Funds")

We inform you that as from 30 September, 2015, within the framework of the organisational evolution within Amundi Group, Amundi will transfer part of its activities to CPR Asset Management. Accordingly, Amundi Luxembourg, acting as Management Company of Amundi Funds (referred to as the "Company") has decided to appoint CPR Asset Management as investment manager (the "New Investment Manager") of the Sub-Funds instead of Amundi. The New Investment Manager is a company incorporated under the French law and regulated by the Autorité des Marchés Financiers, having its registered office at 90, Boulevard Pasteur 75015 Paris – France, with a capital of 46.155.465 EUR. Its principal activity is to offer the business of fund management.

Please be confirmed that the change of investment manager will not affect the Sub-Funds' investment objective and policy, risk profile, fee level, and how they are currently being managed to the extent that:

- The investment management teams will be the same as they will be transferred from Amundi to the New Investment Manager;
- Amundi and the New Investment Manager use the same control and reporting tools;
- Amundi and the New Investment Manager are part of the same group. Both are fully owned by Amundi Group.

All fees and expenses incurred in connection to this change will be borne by Amundi Luxembourg S.A.
