Schroder International Selection Fund – changes to certain share classes with a fixed distribution policy

As part of its annual review of share classes with a fixed distribution policy, the board of directors (the "Board") of Schroder International Selection Fund (the "Company") has decided to lower the fixed distribution rates for a number of share classes (the "Share Classes", which are listed in the appendix to this letter). The distribution frequency of the Share Classes will not change.

As a result of this change in policy, the amount of dividend to be distributed for the Share Classes will be lower than that distributed under the old policy. These distributions may be part-funded out of capital, creating a risk of capital erosion.

The first pay date under the new distribution policy will be announced on 1 January 2016, and the period the new distribution policy will become effective is detailed in the appendix.

The Share Classes' fees will remain unchanged and the costs of making these changes including regulatory and shareholder communication costs will be borne by Schroder Investment Management (Luxembourg) S.A. which is the Company's management company.
