

DBS digibank HK app Activation Promotion (January – February 2024) ("Promotion") Terms and Conditions

- 1. The Promotion shall run from 3 January 2024 to 29 February 2024 (both dates inclusive) ("**Promotion Period**").
- 2. The Promotion is only applicable to existing DBS Treasures and DBS Account selected customers of DBS Bank (Hong Kong) Limited 星展銀行(香港)有限公司 (the "Bank") who have never downloaded and logged in to DBS digibank, DBS iWealth® or DBS digibank HK app before the Promotion Period (the "Customers")
- 3. "DBS Account" and "DBS Treasures" are Customer Segments of the Bank. "Customer Segment" means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
- 4. Only primary account holder is eligible for the Promotion.
- 5. This Promotion is not applicable to individuals who became new DBS Account or DBS Treasures customers during the Promotion Period. Each Customer can only enjoy the Promotion once during the Promotion Period.
- 6. Customers who downloaded and logged in to DBS digibank HK app successfully during the Promotion Period will be entitled to HK\$50 cash reward ("Reward").
- 7. The Reward will be credited directly to the HKD Current Account/HKD Savings Account of eligible Customer on or before 31 May 2024.
- 8. Customer shall maintain a valid HKD Current Account/ HKD Savings Account with the Bank at the time the Reward is given.
- 9. The Bank is not the supplier of the Reward. Any enquiry or compliant regarding the Reward or the goods or services redeemed should be directed to the suppliers. The Bank shall assume no responsibility or liability in respect thereof.

DBS digibank HK 應用程式啟動獎賞 (2024 年 1 月至 2 月) (「本推廣」) 條款及細則
