

## **Notice of Amendment to DBS Terms and Conditions**

- I. Definition of "Bank" under Section B – General Terms and Conditions under Part I – Standard Terms and Conditions will be revised to mean either (i) DBS Bank (Hong Kong) Limited; or (ii) DBS Bank Ltd., Hong Kong Branch (as the case may be)
- II. Addition of definition of "HKICL" under Section B – General Terms and Conditions under Part I – Standard Terms and Conditions
- III. Addition of Section M – Bank Services relating to Faster Payment System ("FPS") under Part IV – Other Services Related Terms and Conditions following the launch of the FPS service on the Effective Date. The section covers:
  1. Bank Services relating to Faster Payment System
  2. Scope of FPS Services and conditions for use
  3. Addressing Service – registration and amendment of Proxy ID and related records
  4. eDDA Service
  5. Customer's responsibility
  6. The Bank's responsibility and restriction of liability
  7. Collection and use of Customer Information
  8. QR Code Services
