The Bank is not obliged to solicit or recommend any Eligible Wealth Management Products to the Customer.

The Terms and Conditions will be reviewed and updated from time to time. In order for you to keep track of the changes and store a copy for future reference, the respective copy as well as this Notice of Amendment will be available for your access or download



within 30 days from the Effective Date at our website at go.dbs.com/hk-wmcsbtc. After 30 days, you may not be able to access or download such documents.

Please note that your retention and/or continuous use of your GBA Wealth Management Connect Southbound accounts and services on or after the Effective Date shall constitute your agreement and acceptance of the above revisions and the revisions shall be binding on you. If you do not accept the above revisions, you can terminate your GBA Wealth Management Connect Southbound account before the Effective Date in accordance with your right of closure provided in the Terms and Conditions.
