#### Notice of Amendment to the Bank Charges Schedule, Equities Trading Club Terms and Conditions and Terms and Conditions for Accounts under Wealth Management Investment Portfolio

#### What is this notice for?

We would like to inform you that with effect from 1 October 2025 ("Effective Date"), changes are made to Section VI. INVESTMENT SERVICES (fees adjustment on Hong Kong Securities and U.S. Securities Brokerage Commission) under the Bank Charges Schedule, Equities Trading Club Terms and Conditions and the Risk Disclosure Statement in the Terms and Conditions for Accounts under Wealth Management Investment Portfolio (Wealth Management Accounts).

In addition, we would like to inform you that the online trading fee of China Stock Connect (which will tentatively be launched in September 2025) will be the same as the current offline trading fee for China Stock Connect as listed on the Bank Charges Schedule Section VI. INVESTMENT SERVICES A. Securities 1) Trade-related services for Shanghai Securities and Shenzhen Securities.

# B. What is the change in the Risk Disclosure Statement of the Terms and Conditions for Accounts under Wealth Management Investment Portfolio (Wealth Management Accounts)?

- The risk disclosure statement for Virtual Assets (VA) and Virtual Assets-related Products under Point 8 in Part 2 of Section A Risk Disclosure Statement of the Terms and Conditions will be updated with key changes listed below:
  - i. Add the definition of the Virtual Asset Futures Contracts (VA futures contracts) and respective risk;
  - ii. Update the definition of VA; and
  - iii. Enrich the content of Legal and Regulatory Risk, Risk of Price Volatility and Risk of Potential Price Manipulation of VA, VA futures contracts and VA-related products.

Please refer to the Terms and Conditions for Accounts under Wealth Management Investment Portfolio for the full version. This Notice of Amendment serves as our notice to you regarding the changes set out above to take effect on their respective effective date(s).

The service charges in the Bank Charges Schedule and Terms and Conditions for Accounts under Wealth Management Investment Portfolio (Wealth Management Accounts) contained in this Notice of Amendment are correct at the time of printing but remain subject to change. The Bank reserves the right to introduce new service charges from time to time.
