website at go.dbs.com/hk-ratesfee-en. After 30 days, you may not be able to access or download such documents. For enquiry or a physical copy of the documents, you may reach out to the Branch for assistance.

Please note that your retention and/or continuous use of your bank accounts and services on or after the Effective Date shall constitute your agreement and acceptance of the above revisions and the revisions shall be binding on you. If you do not accept the above revisions, please close your accounts and services before the Effective Date in accordance with your right of closure provided in the Bank Accounts and Services Terms and Conditions.

Wherever there is a discrepancy between the English and Chinese version of this notice, the English version prevails.
