Notice of Amendment to the Bank Charges Schedule

We would like to inform you that with effect from 1 October 2021 (**“Effective Date”**), the existing fees and charges that the Bank levies for our various services as stated in the Bank Charges Schedule will be revised as follow in the Bank Charges Schedule (Corporate Customers).
