

DBS Mobile Banking Lucky Draw Promotion (“Promotion”) Terms and Conditions

1. The Promotion runs from 1 November 2021 to 30 November 2021 (the “**Promotion Period**”).
2. The Promotion is applicable to customers (the “**Customer**”) of DBS Bank (Hong Kong) Limited 星展銀行(香港)有限公司 (the “**Bank**”) who:
 - i. have maintained a DBS Treasures or DBS Account (“**Eligible Account**”) with the Bank; and
 - ii. have logged into DBS digibank HK app.
3. Each Customer is only entitled to for one Lucky Draw chance (the “**Lucky Draw**”) within the Promotion Period.
4. Customer can only enjoy the Promotion once.
5. Only primary account holder is eligible to the Promotion.
6. One winner will be drawn randomly (“**Winner**”). The Winner will receive the reward listed in below table (“**Reward**”) according to the Lucky Draw result.

7. The Winner must maintain a valid HKD current or savings account with the Bank when the Reward is given. The Cash Reward will be credited directly to the Winner’s HKD current account on or before 31 March 2022.
