

## General Terms and Conditions:

1. The premium discount promotion (as defined in Clause 14 below) ( "**Premium Discount Promotion**") runs from 1 January 2024 to 31 December 2024 ( "**Premium Discount Promotion Period**" ).
2. The merchant coupon promotion (as defined in Clause 15 below) ( "**Merchant Coupon Promotion**") runs from 1 January 2024 to 31 January 2024 ( "**Merchant Coupon Promotion Period**" ).
3. The e-premium coupon promotion (as defined in Clause 16 below) ( "**e-Premium Coupon Promotion**") runs from 18 January 2024 to 14 September 2024 ( "**e-Premium Coupon Promotion Period**" ).
4. The Premium Discount Promotion, Merchant Coupon Promotion and e-Premium Coupon Promotion are only applicable to customers applying for designated insurance plans through DBS Bank (Hong Kong) Limited 星展銀行 ( 香港 ) 有限公司 (the "**Bank**" ) ( "**Customers**" ).

10. Participation in this promotion is subject to there being no abuse/non-compliance by the Customer failing which the Bank will not credit the discount / reward or where the discount / reward has been credited, the Bank may debit the equivalent value of the reward given from the Customer's account without notice and/or take such action to recover any outstanding amounts.

- a. TravellerShield Single Trip Travel Insurance – 45% discount on the premium;

- d. LandlordShield Insurance – 25% discount on the first-year premium;
- e. MasterShield Illness Protection – 25% discount on the first-year premium;

#### 15. Merchant Coupon Promotion

Customers who successfully apply for any of the following insurance products through the Bank's website or Chubb Hotline during the Merchant Coupon Promotion Period shall be eligible to receive merchant coupon:

- TravellerShield Single Trip Travel Insurance – Each policy with after - discount premium of HK\$300 or above will be qualified for HK\$100 supermarket coupon.

For TravellerShield Single Trip Travel Insurance, the merchant coupon redemption email will be sent by Chubb to the email address provided by the Customers in their application within 5 months from the end date of the travel period. The use of the supermarket coupons is subject to the Terms and Conditions imposed by the supermarket coupons supplier. - a. HomeShield Insurance – HK\$300 e-Premium Coupon instant redemption for a premium reduction on the relevant premium payable on top of the Premium Discount offer (promo code: MC300).

Customers who do not input (during online application) or quote (during hotline application) relevant voucher / promo codes are not eligible to the e-Premium Coupon promotion, Chubb will not offer any premium reduction after policies are issued.
