Notice of Amendment to the Trade Finance Service Fee Schedule (Corporate Customers)

We would like to inform you that with effect from 1 January 2026 (“**Effective Date**”), the existing fees and charges that the Bank levies for our various services as stated in the Trade Finance Service Fee Schedule (Corporate Customers) will be revised as follows:
