Notice of Amendment to the Trade Finance Service Fee Schedule

We would like to inform you that with effect from 1 January 2024 ("Effective Date"), the existing fees and charges that the Bank levies for our various services as stated in the Trade Finance Service Fee Schedule (as amended from time to time) will be revised as follows:

This Notice of Amendment serves as our 30 days' notice to you regarding changes to or introduction of the relevant fees set out above. These changes or new fees (as the case may be) will take effect automatically on the Effective Date and will be binding on you.

The fees contained in this Notice of Amendment are correct at the time of printing but remain subject to change. The Bank reserves the right to introduce new fees from time to time.
